(SEE EXCEPTIONS BELOW FOR EXTENDED WARRANTIES AND CONDITIONS). PRODUCTS SOLD BY A.B.C., Inc., BUT NOT OF THEIR MANUFACTURE, WILL CARRY THE STANDARD WARRANTY AS OFFERED TO A.B.C., Inc., BY THE ORIGINAL MANUFACTURER.

WUNDER-BAR REFRIGERATED GLYCOL CHILLERS CARRY A FIVE-YEAR "**PARTS ONLY**" WARRANTY ON COMPRESSOR WITH A ONE-YEAR WARRANTY ON ALL OTHER COMPONENTS.

Automatic Bar Controls, Inc. WILL REPAIR OR REPLACE, AT IT'S OPTION, F.O.B. IT'S FACTORY IN VACAVILLE, CALIFORNIA, U.S.A., ANY UNIT OR PARTS, WHICH UPON INSPECTION AT IT'S FACTORY ARE FOUND TO BE DEFECTIVE WITHIN THE ABOVE MENTIONED PERIODS AND RESERVES THE RIGHT TO MAKE FINAL DETERMINATION AS TO WHAT CONSTITUTES NORMAL WEAR AND TEAR WHEN NECESSARY TO DECIDE WARRANTY STATUS.
