

JoeTap® Beverage Equipment and Equipment Parts Limited Commercial Warranty

Automatic Bar Controls, Inc. (A.B.C., Inc.) guarantees all JoeTap® Products to be devoid of any defects in materials and workmanship for a duration of (i) one (1) year from the date of installation, or (ii) thirteen (13) months from the date of shipment by A.B.C., Inc. of a product covered hereby, whichever time period elapses first (Warranty Period).

Specific Exclusions: OEM Sales, diaphragms, seals, o-rings, silicone or rubber parts, parts in contact with water or the product dispensed and which has become inoperative due to scaled or chemical change, and normal maintenance items. Additional Exclusions: damage resulting from improper voltage, inadequate wiring, abuse, accident, alteration, misuse, neglect, unauthorized repair, improper cleaning or failure to follow installation, operating, or maintenance instructions. Failures within any nitrogen delivery system are excluded from this Product Warranty. This Product Warranty does not cover depleted nitrogen supply or inoperative nitrogen generators due to nitrogen leaks within the JoeTap system.

Any claim under this Commercial Product Warranty must be made no later than thirty (30) consecutive calendar days after the defect discovery.

Any parts shipped to A.B.C., Inc to be considered for Warranty Status must have prior authorization, must follow our RMA process, and must be shipped F.O.B. Destination. A.B.C., Inc. will not accept collect shipments.

A.B.C., Inc. will repair or replace at its' discretion any part(s) which upon inspection are found to be defective within the Period of Warranty. A.B.C., Inc. reserves the right to make final determination as to what constitutes normal wear and tear. Returned shipping costs of repaired or replaced part(s) will be prepaid by A.B.C., Inc. except to original purchasers in Hawaii or Alaska, in which case A.B.C., Inc. will pay shipping costs only to Seattle, San Francisco, or Los Angeles addresses respectively.

Confirmed failures within the sealed refrigeration system (defined as the compressor, evaporator, condenser, and interconnection tubing) within the Warranty Period are eligible for warranty replacement.

A.B.C., Inc. offers a Labor Warranty through Authorized Service Providers and will be responsible for labor costs associated with repair of JoeTap® Products during the Warranty Period. Any labor charges submitted for warranty payment by unauthorized service providers will not be honored.

A.B.C., Inc. shall not be held responsible for parts damaged by alteration, unauthorized service, accident, or abuse. A.B.C., Inc. shall not be held responsible for indirect or consequential damages arising out of the use of their Products or the installation. A.B.C., Inc. shall not be held responsible for costs due to lost shipment, late shipment, replacement, or return. Aforementioned costs include freight, labor, and/ or loss of sales. A.B.C., Inc. assumes no responsibility for damage during transit for which damage claims should be filed against the carrier.

Each Purchaser or Owner of JoeTap® Products manufactured by Automatic Bar Controls, Inc. agrees that this Warranty shall be in lieu of all other Warranties expressed or implied and further agrees to accept and abide by this Warranty without reservation.
